- 1) PUBLIC HEARING: Consideration of Inducement Resolution of the Industrial Development Authority of the County of Prince William to Authorize the Issuance of Tax-Exempt Revenue Bonds in the Amount of \$25,000,000 to Finance The Harbor at Quantico Creek, a 125-Unit Senior Affordable Housing Project for Ages 62+, at or Below 60% AMI. Project will consist of a 5-story building of approximately 151,000 sq. ft., on 7.6 acres to be located at 17950 Curtis Drive, Dumfries, VA 22026 (Potomac District). The proposed project is an age-restricted new apartment complex at below market rate rents. The project will include 81 one-bedroom (640sq ft) and 44 two-bedroom (950 sq ft) senior apartments Michael W. Graff, Partner, McGuireWoods, Bond Counsel to the PWC IDA
